What this means is, you choose the service you want and **ACCESS PLUS** will work to promptly provide it at a low cost. We want to make the legal system and government work better and faster for you.

This is a service like no other. We provide teaching tools and access to vital information needed to make your life better. If you, a family member, or friend seeks justice from our legal system, with our help we can provide access to information and help produce results for you.

SERVICES

- Access to courts, legislators, government agencies, and private organizations.
- Access to send and receive responses for information (e.g., court opinions, blank filing forms, applications, sample/motions and legal briefs) and more.
- If you do not know how to prepare civil or criminal pleadings, **ACCESS PLUS** can provide you the information to teach you, and/or access to lawyers who can represent you.
- We provide calls and emails to courts, police agencies, Ombudsman officials, legislators, parole board, healthcare officials, media outlets, and book stores.
- We provide contact information regarding attorneys, private investigators, and experts, along with a list of things you should know before hiring them.
- We provide computer searches for legal and remedial information.
- We provide information about how to file motions, applications, and petitions in state and federal courts.
- We provide information regarding community outreach programs for parolees and ex-offenders.
- We provide JPay email re-mails. What this means is; you JPay us the letter or message you want to send along with the person's email address, and if possible, we will copy and email it per your request.
- We provide copies of actual complaints, 6,500 motions, applications for leave to appeal, petitions for writ of habeas corpus, certificates of appealability and much more, as filed by attorneys and members of our team who have been litigating and winning cases for over 30 years.
- We draft formal requests for trial court transcripts and other specific records in your court file that you may need to successfully challenge your conviction.

- We draft FOIA requests for police and prosecutor discovery materials and other records, and follow up with emails and

phone calls to obtain the information you need.

We will re-print them in a legal computer format and return them to you, a family member or friend, according to your instructions. **NOTE:** We do not prepare legal pleadings for filing in court or legal agencies; nor do we provide legal advice. We provide ACCESS to the legal tools and information that enables you to do it yourself.

FEES

ACCESS PLUS requires a onetime \$19.95 administrative fee. To **ACCESS** our services, there is an additional \$39.95 program deposit. The cost of each requested service will be deducted from your program deposit until the balance is exhausted. All deposits are non-refundable. **ACCESS PLUS** reserves the right to terminate services if disagreements arise that cannot be satisfactorily resolved by our staff.

All orders and requests for information, whether by regular mail, email, Jpay or phone, will require a processing fee of \$3.00; plus any cost to print, copy and mail. Any phone call that exceeds 15 minutes will require an additional \$3.00 fee. Any expense or cost for information or materials from businesses, vendors or other sources incurred by **ACCESS PLUS** involving the requestors order/request, will be deducted from the requestors account.

1. Information Requests that require downloading and computer printing .20 per page.
2. Draft sample pleadings (including actual motions, briefs and applications upon request) 20 per page.
3. Retyping/reprinting documents in computer format \$1.99 per page, plus an additional \$1.00 per page for editing if requested.
4. Google searches, minimum \$3.00 per 15 minutes.
5. Phone calls from **ACCESS PLUS** staff to courts, lawyers, experts, investigators, government agencies, legislative officials, minimum \$3.00 per 15 minutes.
6. Draft letter requests from **ACCESS PLUS** staff for discovery materials per FOIA or MCR 6.433 (b) \$3.00.
7. Jpay/email re-mails requests, minimum \$3.00.
8. Questions, general inquiries, or follow-up questions seeking clarification regarding information received or sent to the requestor from **ACCESS PLUS** will require an additional \$3.00 unless based on an error made by **ACCESS PLUS**.

Unlike expensive legal agencies that charge hundreds of dollars for these services, **ACCESS PLUS** provides them at a low cost that is affordable.
