

What we do? We are a National Online Database for Wrongfully Convicted Prisoners, plus more. We raise awareness of wrongfully convicted prisoners by enabling them to share their profile and story on our networks and reveal proof of how they were wrongfully convicted. Joining our networks will provide prisoners exposure to people and organizations that have the power to open doors and provide the justice to which they are entitled.

It is our goal to obtain investigations into cases where serious violations have occurred to determine the truth and correct wrongful convictions. **This is an exclusive offer for special cases only.**

If you want people to take notice of a wrongful conviction and want to access our programs, send us:

1. The inmate's full name and prison number;
2. The inmate's date of birth;
3. The crime(s) the inmate was convicted of;
4. The date of the inmate's conviction;
5. The date and length of the inmate's sentence(s);
6. The state & county where inmate was sentenced;
7. The inmate's court file docket number;
8. The inmate's name, number and address (Jpay or other electronic service) where the inmate wants all responses sent;
9. What assistance is the inmate seeking (e.g., Attorney, Private Investigator, Conviction Integrity Units, College Law Clinic, Innocence Projects, Medical Expert, Ballistics Expert, Biographical Expert, Fire Expert, Crime Scene Reconstruction Expert, Mental Health Expert, Toxicology Expert, Blood Spatter Analyst, Psychologist, or Criminal Behavior Expert.

10. A 500-word (3000 character) summary of why the inmate was convicted & sentenced and what new evidence proves s/he was wrongfully convicted to require a new trial or sentence;

You or the inmate must describe his/her story in a short, well written factual summary that gets straight to the point, captures the reader's attention, and inspires them to get involved with the inmate's cause.

All 500-word case summaries must be sent to us by email, Jpay, or other electronic means. We will use the photo provided by the DOC's website, until you or the inmate provides us with a different photo, either by email or US Mail.

We will post the inmate's photo and case information on our website. Any modifications or revisions to the profile once it is up-loaded on our website will require a \$25 fee, so please make sure the inmate's summary is current, accurate and says what s/he wants it to say. Access Plus will review and correct any spelling or grammatical errors.

Once the profile is posted, if there are any specific people or organizations that you or the inmate wants to see your profile and consider your case, we encourage you to reach out to them and tell them to go to our Access Plus network(s). Our community of professionals uses our networks to screen for individuals they want to help.

Inmates can send us their profiles and we will store it in our system and when the payment is received from a family member or friend, we will post the inmate's picture and profile on our network.

ONLINE DATABASE FEES

For \$80.00 (+ tax) we will post the profile on our website for 1 year, which is visited by thousands of people, including private investigators, experts, exonerees, Innocence Projects, Conviction Integrity Units, law schools, media outlets, legal organizations and attorneys.

For \$130.00 (+ tax) we will post the profile on our website AND also add it to our Access Plus Facebook page multiplying its exposure to these same people and more. Through our Network and Facebook, inmates can tell their story to the world!
