

I Antonio Stone met ARKeone Broaden through a mutual acquaintance by the name of Martez Johnson victim and another person by the name Ham ARKeone introduced me to an acquaintance of his who's name is Cody Clark.

On or about late June 28 2015. I attended Red Roof inn Hotel, in Southfield Michigan North western, Hwy for a Hotel Room party. several STRIPPERS were the entertainment for the night and also in attendance at this party, were both MR ARKeone Broaden, Martez Johnson and Ham. there was plenty of drugs & alcohol available and APPARENTLY ARKeone Broaden had been drinking and was passed out in a section of the room away from the rest of the party. midway through the night, MARTEZ announced he was leaving to drive ARKeone home. who was wasted and in no shape to drive. Martez, stayed behind and didn't leave.

I got up to use the bathroom, and as I was looking for shirts, I found a white iPhone, in between, the toilet & a sink of the bathroom, I tried using this phone and found out it was Arkoon's. Despite this, I had no intention to return the cell phone to Arkoon.

For the entire time I was in possession of this cell phone I used it to call not only the victim martz Johnson, I also kept in contact with cody clark and at some point met both mr clark & mr Johnson prior to the incident to discuss robbing Andre martz half brother, in secret. however, cody and I had other plans and were going to cross martz out of the deal. the plan was to Rob Andre thomas of 3.10 pounds of marijuana and 25 thousand in cash.

I stole a white Dodge caliban and drove martz Johnson & cody clark to Anders wood house on Hayden Street.

Both he, the victim MARTIN Johnson and Mr Cody Clark exited the vehicle and entered 1816 1/2 Heydon Street to carry out the Robbery. After only a few minutes, shots rang from inside 1813 1/2 Heydon Street, the Cody Clark came running out the house while Andre Thomas chased him down shooting at him. As I began pulling off toward 7 miles Andre shoot out the Rear window and I escaped the shots and picked Cody up on on hour, seven miles and we fled the scene. ARKOSH Broadon had absolutely no involvement in what occurred on the date in question, Jan 28 2018, and this was a Robbery orchestrated by myself and Mr Cody Clark.

I have no interest in the above mentioned and, make this statement being of sound mind & Judgment to here by freely provided, personal knowledge of the aforementioned
